2024 REALTOR® Good Neighbor Award

Eligibility Criteria

1. Nominees must be REALTOR® members of RVAR in good standing for the entire current application year.
2. Nominees should have contributed to an organization / program that improves the livability of a local community, as defined by the area served by RVAR/MLS jurisdiction. Those activities aren't limited to real estate or housing issues, and may include such things as crime prevention, youth mentoring, and homelessness prevention.
3. Nominees should have made a significant contribution of personal time, but contributions of money, materials or other resources will also be considered.
4. Nominees will be evaluated on level of personal contribution, impact of contribution, broadness of impact and the project's suitability as a role model for other Affiliates.
5. The award is intended to recognize individual contributions, not Association or company wide efforts. However, if an individual within your company can be singled out as instrumental to the success of a group effort, he or she is eligible. If the achievements of two people (such as a married couple or co-founders of an organization) absolutely cannot be separated, they can enter as a pair and their entry will be considered as one.
6. At least 50% of the nominee's community work must have taken place between November 1, 2023, and October 31, 2024, but ongoing efforts outside that time frame that demonstrate a depth of commitment will also be considered.
7. Nominees should be able to document the results of their individual involvement through testimonials and/or published reports from the organization they serve or the people they helped.
8. Nomination must be accompanied by a completed entry form to be considered. (Affiliates may nominate themselves, may be nominated by another RVAR member or by the organization they served.)
9. Nomination will not be considered if the applicant has won this award within the last 5 years.
10. To be considered all applications must be complete.
11. Winner will be presented a \$1000 check from RVAR for the charity of their choosing. The check may not be divided but must be presented to a single charity. The charity that receives the check must be in, or have a branch in, the RVAR/MLS jurisdiction.
